SUBJECT: 2016 Form 1 Statement of Financial Interests

Please be advised that we have been authorized by the Commission On Ethics to receive the 2016 Financial Disclosure by e-mail. This is an option made available to filers this year; however, they may still submit the Form 1 by mail if they prefer this method.

As you know, with respect to the 2016 Form 1s, the initial filing date is July 3. That being said, we are requesting that you review the list of your filers on the Commission of Ethics website www.ethics.state.us.fl to determine which of yours are still outstanding. If there are names on your list that should not be on the list, please write to Shirley Taylor, Commission on Ethics, PO Drawer 15709, Tallahassee, FL 32317-5709 to remove them. You can also e-mail her at disclosure@leg.state.fl.us, but she will not remove someone via a phone call. In turn, Shirley will notify me to remove the name. You can review the status of your filers at any time by visiting their web site.

Please remember that anyone who is delinquent as of September 1, will be assessed an automatic fine of \$25 per day, so it is imperative that the correct names are on the list. Remember that anyone who served as of December 31, 2016 is required to file a 2016 Form 1 even if they left the position in 2016. In addition, if they left after January 1, 2017 they must also file a Form 1F. (If they left prior to December 31, 2016, they should not be on this list, as they are not required to file a Form 1. Instead, they should be filing a Form 1F for 2017.) Both Forms can also be downloaded from the Commission's website.

Any assistance you can offer in encouraging your filers to return their Form 1 before we send out the second notice and/or the final delinquent list, would be greatly appreciated. Thank you in advance for your efforts again this year.

Requirements:

- ♦ **Each page must be scanned separately;**
- ♦ **All documents must be PDF's & No mail sizes over 5MB should be sent at one time.**

How to Submit Form 1 Statement of Financial Disclosure by e-mail:

Step 1. Scan each page of the documents that you will be submitting you must scan both sides of each submitted document.

Be certain to sign the form on the line provided and include any additional documentation that you deem necessary.

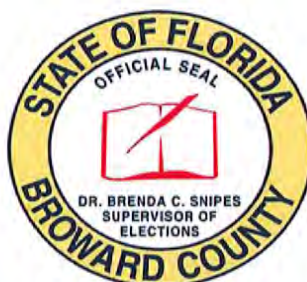
Step 2. Open a new email and type Form 1 on the subject line.

Step 3. Attach all documents to be submitted, including your signed Form 1.

Step 4. Send your e-mail to: jway@browardsoe.org and cc: aperri@browardsoe.org.

Step 5. Our office will provide an email confirmation upon receipt of your Form 1 email submission.

Step 6. Verify that your information was updated on the Commission On Ethics Website at: ethics.state.fl.us.

If you filed a form and no date appears in the "Filing Requirement Fulfilled" column, then the Supervisor of Elections or Commission on Ethics has not yet recorded receipt of your form. Generally, forms are recorded within a few days of receipt. If you are concerned about the status of your form, please use the contact information under "Statutory Filing Requirement."

Section 112.31445, Florida Statutes, requires that all CE Form 6 Full and Public Disclosure of Financial Interests, other than those of Judges and Judges of compensation claims, be posted online. Before being posted online, any information required by law to be maintained as confidential must be redacted. For persons other than those who have filed as candidates with the Department of State, this process may take up to 5 business days. Processing times for Form 6 disclosures filed with the Department of State at qualifying may exceed 5 business days. Those forms may be available for viewing on the [Department of State](#) website before they are available here.

Once we have logged in a Form 6, the status will contain the date received and the message "Form Available Soon!" When the Form 6 becomes available online, the Filing Requirement Fulfilled status will have a link to "View Form."
