In accordance with your request and subsequent discussions between members of our association and yourself, this Task Order between Keith and Schnars, P.A. ("CONSULTANT"), and Turtle Run Community Development District ("CLIENT") for professional services is submitted for your consideration and approval in accordance with the District Engineer Agreement dated March 24, 1987, as amended, between the parties. I. PURPOSE OF AGREEMENT/PROJECT DESCRIPTION

The purpose of this Task Order is to outline the scope of services recommended by CONSULTANT and accepted by CLIENT and to establish the contractual conditions between CONSULTANT and CLIENT with respect to the proposed services.

CONSULTANT shall provide professional services associated with the Security Wall for the Turtle Run Community Development District located in Coral Springs, Florida.

II. SCOPE OF SERVICES

Task 22033: Specific Purpose Survey – Security Wall

CONSULTANT shall provide a Specific Purpose Survey depicting the above ground improvements for Lot 1 through Lot 4, Block 1, as shown in the plat of Turtle Run, recorded in Plat Book 131, Page 12 of the Broward County Records. Limits will be twenty (20) feet centered on the Northern Right of Way of Turtle Run Boulevard extending from the intersection of Turtle Run Boulevard & N.W. 43rd Place to the most Eastern point of Lot 4 along Turtle Run Boulevard. Above ground features located will include utilities, concrete, asphalt, fences, trees (diameter and generic species), hedges, and any other permanent fixtures within the limits described above.

Elevations shall be obtained throughout the subject area on an approximate twenty five foot (25') grid and will be relative to the National Geodetic Vertical Datum of 1929 (NGVD '29).

All survey work shall be performed in accordance with the Standards of Practice as set forth by the Board of Surveyors and Mappers pursuant to Rule 5J-17 of the Florida Administrative Code, pursuant to Section 472.027 Florida Statutes.


